### Liability/Damage:

I accept that risk and will not hold the Fun Zone, it's staff or owners, responsible for injuries that may occur while participating in any activity at the Fun Zone.

I have viewed on svfunzone.com and understand the parking restrictions associated with the Fun Zone building. I understand the risk and damage that could occur to my vehicle if I park on the south or north side of the building inside the restricted area. I take full responsibility of damage to my vehicle if I do not follow posted signs and park within the "slide zone". I will not hold the Fun Zone liable for any damages occurred to my vehicle or myself I do not heed to parking restrictions and/or walk under slide zones.

All damages to the building that occur during a rental is the responsibility of the renter to fix or replace. This includes but is not limited to broken mirrors, broken lights, broken windows, stained carpet in the balcony game area and damaged or broken furniture and fixtures. Security cameras are in use at the Fun Zone and any tampering or damage to those cameras will result in the renter replacing or repairing them. Any changes to audio or video equipment are prohibited. If a technician has to rewire any electronics – you will be responsible to pay for his time.

I understand that the thermostat in the building is not to be adjusted or tampered with. If adjusted during a rental – a \$100 fee will be charged. I agree to fulfil the cleaning checklist if I choose to clean the building myself. If the building is not cleaned properly - I understand I will be charged a \$50 cleaning fee. I also understand that if I choose to pay \$75 to have the cleaning done for me and the building is left in an excessively dirty state - I will be charged an extra fee to return the building to its original state. There is a \$20 NSF fee for returned checks. <u>NO</u> **SMOKING IS ALLOWED IN THE BUILDING. All Cleaning fees to remove smoke will be at your expense.**
